Resolution 2024-06 Cannabis Delegation Resolution. The Fish Lake Township Board passed a resolution delegating its administrative powers and authority over the registration and compliance checks for cannabis and hemp retailers to Chisago County. This decision aligns with Minnesota Statutes, which require local governments to oversee compliance checks and allow them to limit cannabis retailer registrations. By partnering with Chisago County, the Township aims to centralize these responsibilities at the county level for more effective administration. The resolution was officially adopted on November 11, 2024.

County Road 10 Project Update: The board reviewed a letter from Ben Hobert, P.E., Assistant County Engineer for Chisago County relaying project updates for the reconstruction of County Road 10. The 4-mile stretch from Cedarcrest Trail to the County line is nearly complete with the remaining work of: final layer of asphalt, gravel shouldering, final pavement markings, turf restoration and removal of any remaining erosion control items to be done in Spring 2025.
